



GDPR LEGAL STATEMENT
based upon Regulation (EU) No. 679/2016

I, the undersigned _____, hereby declare that, in accordance with the requirements of **Regulation (EU) 679/2016**, hereinafter called GDPR, I have been informed that "Ovidius" University of Constanța, with headquarters in Constanța, Mamaia Blvd. no. 124, postal code 900527, phone/fax +40 241 606407, +40 241 606467, email: rectorat2@univ-ovidius.ro, legally represented by Rector - Professor Ph.D M.D Sorin Rugină, as personal data controller, is legally obliged to collect and process my personal data by automated/manual means in order to organize and conduct the admission exams within the University, according to Law 1/2001 - Law of National Education and secondary legislation.

Personal data: name and surname, name and surname of parents; date and place of birth; home address; urban/rural origins; personal identification number (CNP); serial number of identity document; signature; photograph from the identification document and the entrance pass; phone number; e-mail address; name of the institution/educational institution previously attended; series and number of the study diploma; work place (if applicable); position/profession (if applicable); medical information attesting the medical ability to acquire the student quality; marital status; ethnicity (if applicable); religion (if applicable), are obtained from the filled in and signed application forms for the admission exam organized by "Ovidius" University of Constanța, as well as from the supporting documents attached to them. This information is introduced by the University in its database in any material (on paper) and electronic form.

I hereby give my consent for my personal data regarding my ethnicity to be processed, in case I apply for a place which is destined for members of that ethnicity, as well as my personal data regarding my religious belonging, in case I apply for studies within the Faculty of Theology, as well as medical personal data included in the medical certificates.

The purpose of the data collection is the instrumentation of the application process/procedure of "Ovidius" University of Constanța, according to my request, in order to initiate and execute the specific contractual legal relations between the undersigned and the University, as well as to fulfill the legal obligations of "Ovidius" University of Constanța, to administer, process and safely transmit my personal data, including through RMU and the other public registers provided by law and only for the purposes of the legislation in force.

The legal basis for collecting and processing my personal data for the above-mentioned purpose is: my consent, the application form for the admission contest organized by "Ovidius" University of Constanța, Law no. 1/2011 - The Law of National Education, Law no. 16/1996 of the national archives, republished, with subsequent amendments and completions.

At the same time, I took note that my personal data is transmitted by any means of communication to the following recipients: the concerned person (the undersigned) – by nominal public display of the admission and information regarding the undergoing of the admission process – as well as public institutions/authorities (eg. The Ministry of Education and Research), tax authorities, verification and control authorities, under the conditions established by law, or other public or private entities whose activities are incidental to the activity of "Ovidius" University of Constanța, or which have a direct or implicit connection with the instrumentation of the act or procedures for which I have initiated legal relations with the University and who, in turn, are personal data controllers.

According to **Regulation (EU) No. 679/2016**, I have been informed that I have the following rights: the right to restrict the processing of my personal data, as long as this is not contrary to the legal obligations of the

University; the right to data portability; the right of free access to my personal data; the right to rectification or deletion of my personal data (the "right to be forgotten"), as long as this does not contradict the University's legal obligations; the right to withdraw at any time the given consent in the specific case where the collection and processing of my personal data is based on consent and does not involve a contractual or legal provision requiring the collection and processing of data; the right not to be subject to an automated, individualized decision, including the creation of individual profiles. I have been informed that in order to exert the above mentioned rights I may address the institution either at its headquarters or at the following e-mail address: dpo@univ-ovidius.ro.

I also became aware that my personal data will be processed / retained within "Ovidius" University of Constanța in accordance with the legal provisions on the basis of which processing deadlines are regulated of such data, such as, for example, the legal provisions governing the archiving of documents or the legal provisions regulating the activity and functioning of higher education institutions.

I have been informed that I must provide the data necessary for achieving the aforementioned purpose and that the refusal to supply or supplying these data incorrectly and incompletely determines the impossibility of initiating or, as the case may be, the execution and completion of the act or procedure by the University, as it would result in non-compliance with specific legal regulations in the field of education.
